- Of the residents surveyed, 75% said there were NO health programs in their community.

## NEIGHBORHOOD PLANNING UNIT Z

### Overall Findings in NPU-Z

- 7 % of residents surveyed are female
- The average age of the residents surveyed is 48 and up
- Most residents who completed the survey had an income at or below \$ 15,000, which is below the metro Atlanta area's average income of \$ 27,000.
- Of the residents surveyed, 7 % said there are NO health programs in their community.
- 67 % of the residents surveyed did NOT have health insurance.
